**SHB40115 Certificate IV in Beauty Therap** is a nationally recognised qualification under the **Hairdressing and Beauty Services Training package (SHB)**.

This qualification has been designed for those individuals who wish to be employed as Beauty Therapists, providing a range of beauty treatments and services, including waxing, intimate waxing, lash and brow treatments, manicure, pedicure, tanning, basic make-up services, eyelash extensions, body massage, body treatments, facial treatments, acrylic and gel nails as well as advising on beauty products and services and all the employability skills required to undertake this position to the highest level. Work is typically conducted in beauty salons and day spas.

**SHB40115 Certificate IV in Beauty Therapy may also be utilised as a stepping stone to higher qualifications. Suggested qualifications are SHB50115 Diploma of Beauty Therapy.**

### Course Duration

Part Time option 1 day or 2 evenings per week – 66 weeks .

Full Time option 4 days per week – 23 weeks



### Tuition Cost Payment Options

### Student Requirements

**Uniforms:** WA Academy have a set uniform for this qualification and the uniform is compulsory for attendance. Allow approximately \$300 for a beauty tunic and dress pants. Uniforms are purchased direct from our Uniform supplier information available on enrolment.

**Beauty units:** Students will be required to supply a towelling body wrap and headband for beauty units.

**Make-up units:** Students will be required to supply mascara and disposable mascara wands.

**Portfolio:** WA Academy utilizes in some units portfolios, assignments and log books to allow formative assessment through the duration of the qualification these are completed outside of class and at the students cost.
