Course Duration

Enrol in Certificate III Make-up with no previous make-up qualifications with a choice of full or part time. Full time – 3 days per week for 10 weeks – Part Time 1 day or 2 evenings per week for 30 weeks.

SIB20110 Enrol in Certificate III Make-up with a Certificate II in Retail make-up and skincare or equivalent qualification – 1 day per week or 2 evenings per week for 15 weeks.

SHB20116 Enrol in Certificate III Make-up with a Certificate II in Retail Cosmetics – 1 day per week or 2 evenings per week for 21 weeks.

Student Requirements

Uniforms: WA Academy uniform top to be worn with black professional pants and enclosed black shoes.

Portfolio: WA Academy utilises in some units portfolios, assignments and log books to allow formative assessment through the duration of the qualification these are completed outside of class and at the students cost.

Course Overview

SHB30215 The Certificate III in Make-up is a nationally recognised qualification under the Hairdressing and Beauty Services Training package (SHB).

This qualification has been designed for those individuals who wish to be employed as make-up artists or work as freelance make-up artists to design and apply make-up for a range of purposes and occasions across the beauty, fashion, media and entertainment industries. These individuals will possess a range of well-developed skills including working cooperatively with a range of individuals from photographers, fashion stylists and media production staff. Work is typically conducted as part of a team or on a freelance basis in settings such as make-up studios, retail cosmetic counters, fashion and media sets and photography studios.

SHB30215 The Certificate III in Make-up may also be used as a stepping stone to higher qualification in make-up such as Diploma of Screen and Media – Specialist Make-up services, alternatively hair and/ or beauty therapy qualifications.

Tuition Cost Payment Options


